



Guidelines for Duck Zones and Split Seasons



The following zone/split-season guidelines apply only for the *regular* duck season:


- 1. A zone is a geographic area or portion of a State, with a contiguous boundary, for which independent dates may be selected for the regular duck season.
- 2. Consideration of changes for management-unit boundaries is not subject to the guidelines and provisions governing the use of zones and split seasons for ducks.
- 3. Only minor (less than a county in size) boundary changes will be allowed for any grandfathered arrangement, and changes are limited to the open season.
- 4. Once a zone/split option is selected during an open season, it must remain in place for the following *5 years*. Any State may continue the configuration used in the previous 5-year period. If changes are made, the zone/split-season configuration must conform to one of the following options:
 - 1. No more than four zones with no splits.
 - 2. Split seasons (no more than 3 segments) with no zones
 - 3. No more than three zones with the option for 2-way (2-segment) split seasons in one, two, or all zones.







South Zone (Hwy 10) Average (16-22)

North Zone (Hwy 10) Average (16-22)




Current Zone Structure Harvest by Week







South Zone (Hwy 10) Average (16-22)








Comparison of 3 Southern Zone Options (2016 - 2022)




South Zone (Hwy 64) Average (16-22)

*** 57% of North Zone harvest occurs between Hwy 10 and 64




North Zone (Hwy 10) Average (16-22)






North Zone (Hwy 8) Average (16-22)

Participation in Waterfowl Hunting and Opinions of Hunting Regulations








Zone Structure Feedback


- North and South Zone season starting on the same date
- Warmer seasons resulting in increased interest in later season dates in North Zone
- Reminder this is only a five-year commitment
- USFWS reviewing proposals from multiple flyways for other options 2 zones with 2 splits, 3 zones with 2 splits, 1 non-contiguous zone
- Positive feedback from public regarding open water zone (shown growth in participation 2019 = 4% 2021 = 9%
- Feedback from public and NRB regarding Miss. River Zone and South Zone being the same except for a 2-day difference












3 Zone North/South- HWY 64






























Path moving forward
