## 2025 Conservation Calendar Rules & Regulations

- 1. Cost of calendar is \$30 each. All monies collected from calendar sales will go directly to WWA.
- 2. A maximum of 4,500 calendars will be sold.
- 3. 365 WINNERS will be awarded more than \$80,000 in retail prizes. Winners will be drawn through a raffle conducted as outlined below:
  - a. Single drawing date per month, multiple prize drawings on that date: The prizes shown for each calendar date in a given month are a visual representation of the prizes to be drawn at the monthly drawing. A single drawing event for each month's prizes will be held on the second Wednesday of each month during 2025, except the first drawing will be held on Wednesday 22 January. The drawing will be held at The Marsh Inn, 220 South Cty Rd W Reedsville, WI 54230 at 6:00 pm to select the winners of that month's prizes as listed. On the drawing date, the drawing order for each prize will be sequentially as shown on the calendar and at our website: <u>https://www.wisducks.org/wwa-calendar-raffle/</u>. That is, the first stub drawn will be for the first prize listed, the second stub drawn will be for the second prize listed, etc.
  - b. Drawing procedure: All calendar stubs for the year will be placed in a single container. After drawing each winning calendar ticket stub, the winner's name and contact information will be recorded, and the ticket stub returned to the drawing container for the next drawing and the container re-shuffled. Each ticket stub will have an equal opportunity to be drawn for each prize.
  - c. Winners need not be present to win.
  - d. The Wisconsin Department of Revenue requires the Wisconsin Waterfowl Association to report all prizes with a value greater than \$1000 to the WI Department of Revenue. Winners of any prize with a value of \$1000 or more will be required to provide a Social Security Number prior to taking possession of the prize.
  - e. This raffle is conducted under the State of Wisconsin Raffle License #R0010916-A-64101.
- 4. A calendar raffle purchaser does not need to take possession of the calendar itself as long as the information on the ticket stub for the drawing is complete and correct.
- 5. All firearm winners will be subject to Federal Firearms Regulations. Long gun winners must be eighteen (18) years of age. Pistol winners must be twenty-one (21) to redeem gift cards for handguns. Wisconsin's Division of Gaming has advised WWA that no other persons may be substituted for the winner of a prize to circumvent this requirement, including parents. WWA is not responsible for winner's inability to obtain a firearm in accordance with any local, state or federal regulations, and no alternate prize or compensation will be offered. Furthermore, due to the availability of certain firearms, WWA reserves the right to substitute any firearm listed with an alternate firearm of equal or greater value.
- 6. Names of winners will be published online at <u>www.wisducks.org/wwa-calendar-raffle/.</u> WWA staff will make reasonable attempts to notify winners based on emails, phone numbers and addresses in the days following the drawing. If notification is not able to be made after three attempts, and one month has expired since the drawing, the prize may be considered forfeit.
- 7. A list of winners may also be obtained via written request, along with a stamped, self-addressed envelope, to WWA; PO Box 427, Wales, WI 53183.
- 8. Wisconsin Waterfowl Association reserves the right to cancel the raffle and return all monies collected to the purchasers of the calendar should a minimum of 1500 calendars not be sold by the first drawing. If such an event occurs, the purchaser may keep the calendar.
